

## **Cadence Bank Declares Quarterly Common and Preferred Dividends**

TUPELO, Miss. and HOUSTON, Oct. 26, 2022 [/PRNewswire/](#) -- At its regular quarterly meeting today, the board of directors of Cadence Bank (NYSE: CADE) (Cadence) declared a quarterly cash dividend of \$0.22 per share of common stock. The common stock dividend is payable on January 3, 2023, to shareholders of record at the close of business on December 15, 2022.

The board of directors also declared a quarterly cash dividend of \$0.34375 per share of Series A Preferred Stock. The preferred stock dividend is payable on November 21, 2022, to shareholders of record at the close of business on November 4, 2022.

Cadence earlier reported financial results for the third quarter of 2022. Net income available to common shareholders was \$121.0 million, or \$0.66 per diluted share, and adjusted income available to common shareholders was \$143.7 million, or \$0.78 per diluted share.
