

## **BancorpSouth, Inc. Announces Increase in Quarterly Dividend to \$0.14 per Common Share**

TUPELO, Miss., July 26, 2017 /[PRNewswire](#)/ -- At its regular quarterly meeting today, the Board of Directors of BancorpSouth, Inc. (NYSE:BXS) declared a quarterly cash dividend of \$0.14 per common share, which represents an increase of \$0.015 per common share, or 12 percent, compared to its most recent dividend paid on July 3, 2017. The dividend is payable October 2, 2017 to shareholders of record at the close of business on September 15, 2017.

BancorpSouth earlier reported financial results for the second quarter of 2017. Net income was \$37.9 million, or \$0.41 per diluted share, and net operating income – excluding MSR – was \$38.8 million, or \$0.42 per diluted share.
